

Privacy policy

In the Privacy Policy, we provide information on how we obtain personal data from you, how we use, process and secure it. The Administrator of personal data is BM QUEER Katarzyna Górna, ul. Kosmatki 68F, 03-982 Warsaw (hereinafter referred to as BM QUEER), as a company providing introductory and matrimonial services for the people, makes every effort to ensure that your privacy is respected and the personal information provided is protected when using the services of BM QUEER.

We have prepared the privacy policy in accordance with the RODO, Regulation of the European Parliament and of the Council of Europe (EU) 2016/679 of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data. The new rules will apply from May 25, 2018.

1. Data collected by BM QUEER during registration, profile creation and payment.

BM QUEER will collect the following personal data from you via the queer-bm.pl website and through other forms of contact and payment for services:

Data collected during registration:

- a. User's e-mail address
- b. gender
- c. date of birth
- d. name and surname
- e. telephone number

Providing the above data is voluntary but necessary for registration.

In addition, in order to create an individual Client Profile, BM QUEER collects the following information from users: their photos, data in the Profile: height, eye color, hair color, education, current occupation, place of residence, country, marital status, description of own character, preferences, data on expectations towards the partner, etc. Users voluntarily disclose them to the public and agree to disclose them to other users in an anonymous form

Entering the name in the profile questionnaire is for the Office's attention only, necessary for the performance of the contract, invisible to users. We do not share names with other users or third parties.

In payment transactions via transfers 24 and the selected Bank, providing personal data is only for accounting purposes, invisible to users (only for the Office Administrator)

Providing the above data is voluntary and requires your consent and is necessary for the implementation of the matrimonial service. Otherwise, the ordered service may not be performed.

2. Who we share your personal data with.

- a) registered BM QUEER Users who have concluded an Agreement for the use of services.
- b) business entities conducting payment activity (banks, payment platform - Przely24.pl) - in order to make a transfer order and make the payment (ensure the service is operational) or refund the fee.
- c) an IT company that supports BM QUEER, solely for the purpose of repairing or updating the Office (graphic changes, adding panels, information, technical data, etc.)

- d) entities operating postal or delivery company, only for correspondence.

Data is not transferred to third countries. In such cases, the amount of data transferred is limited to the required minimum. In addition, the information you provide may be made available to competent public authorities, if required by applicable law.

3. Data collected (automatically) by the website.

The queer-bm.pl matrimonial website does not automatically collect any data, except for the data contained in cookies and logs while using the website.

BM QUEER uses the "cookie" technology. These are short text files saved on the computer disk, on the memory card of a smartphone or tablet, from which the user connects to a supported website and only the encrypted identifier of this computer system is saved. The cookie file in no way enables the identification of the visitor to the site and no information is stored that could enable such identification.

Cookies files are used for the following purposes:

- a) remembering data when filling in forms on the BM QUEER website
- b) assessing the use of the Website, adjusting the content of the pages to the User's preferences
- c) creating website statistics and monitoring website traffic by saving data that in no way can identify the person and only help the Administrator understand how Users navigate on the website
- d) identifying the User's uniqueness by identifying his IP address.

The website uses two types of "cookies" - session and permanent. Session files are temporary files that are stored on the User's end device until they leave the website or turn off the software (web browser).

Permanent files - they are stored on the User's end device for the time specified in the file parameters or until they are deleted by the User. Ending the browser session or turning off the device does not automatically delete them.

Saving text files on the User's computer disk is allowed provided that the User is informed about it - legal basis from Article 173 of the Telecommunications Law of July 16, 2004. However, there is no provision in the regulations about the method of informing the User about the fact of text files on the User's computer disk. Therefore, it is customary and commonly accepted practice to post information on this subject in the section: Privacy Policy.

Please be advised that commonly used browsers allow you to disable the use of "cookies" by selecting the appropriate settings in a given browser. At the same time, restrictions on the use of "cookies" may affect some of the functionalities on the BM QUEER website.

By using BM QUEER, the User agrees to the processing by the Administrator and other entities providing similar services, e.g. advertising, statistical, etc. regarding his data contained in cookies in the manner and for the purposes set out above.

In addition, BM QUEER uses technology for the company's Google Analytics statistics. It enables the structure and content of the QUEER BM to be improved. The data collected by Google Analytics is protected - see. Google Privacy Policy. Google Analytics only uses truncated anonymous IP addresses that do not allow users to be identified.

4. Processing of personal data.

We process your personal data because it is necessary to fulfil a contract, including to:

- a) Implementation of the main BM QUEER service - performance of the Agreement for the provision of matrimonial services. The services consist in presenting a matrimonial offer to other registered Users of the Office. Providing the above data is voluntary and requires your consent and is necessary only for the implementation of the above-mentioned purpose.
- b) setting up and managing your profile and providing support for your profile, transactions and solving technical problems
- c) Handling of requests that you send to us (e.g. by e-mail)
- d) Contacting you, including for purposes related to the provision of services.
- e) In addition, the law requires us to process your data for tax and accounting purposes.

Providing data is not a statutory requirement but a contractual requirement and is voluntary, but necessary for the performance of the Agreement. Users voluntarily make them public and agree to disclose them to other BM QUEER users in anonymous form in connection only with the User Name (first name) in or for other data processing purposes (newsletter, interest circles, marketing ...), sent only by BM QUEER

We store your personal data for the duration of the concluded Agreement, and also after its termination, for the purposes of:

- a) pursuing claims in connection with the performance of the contract,
- b) fulfillment of obligations resulting from legal regulations, including in particular tax and accounting,
- c) preventing abuse and fraud,
- d) statistical and archiving,
- e) for a maximum period of 10 years from the date of completion of the contract.

After the expiry of the Agreement, the Administrator may extend the processing period by informing the User via e-mail about reactivating the Profile. Thus, the User agrees to the further posting of his Profile and data processing, or may submit a request to remove his data from the Office

5. Technical measures for data security.

BM QUEER makes every possible effort to secure the data of our Users and protect them against the actions of third parties. We use the necessary security for servers and Website connections, in particular:

a) Access to data by the Administrator - an authorized employee

Users' personal data are stored on secured media in a closed and protected room. Only authorized persons working for the Bureau, who are obliged to keep the information obtained secret, have access to them.

b) Encryption of connections and securing electronic payments

When making payments via the Przelewy24 electronic payment system, a trustworthy SSL security certificate is used. The Przelewy24 system does not store any information regarding access to bank accounts or credit card numbers. This information is entered only on the official websites of banks and in the event that the user has an account with payment operators in the PayPal system.

c) Other forms of protection offered by BM QUEER

The User's surname is only for the attention of the Office Administrator, we do not pass it on to anyone. After accepting the profile, at the first contact between the users, they will reveal their identity in writing or by telephone upon mutual consent, and it will be communicated via BM QUEER.

User photo protection. Photos of BM QUEER users are not shared.

Actions taken by BM QUEER to protect Users' personal data are sufficient, however, the Users themselves must comply with the security rules.

Website administrator, in accordance with art. 6.1. letter f. RODO reserves the right to automatically filter and delete messages for prohibited in accordance with our Regulations. In addition, we also reserve the right to process Users' data when the account validity period has expired and the User has not requested us to delete their data.

6. BM QUEER User Rights.

The BM QUEER user has the right to:

- a) access, view and edit data at any time during the term of the contract
- b) to request information on the content of the stored data
- c) to request changes, blocking or deletion of data, as well as the right to rectify errors, supplement or update data.
- d) to object to their processing
- e) to report the deletion of data processed after the expiry of the contract
- f) transfer of data to another Data Administrator (to the extent specified in Article 20 of the RODO)

The consent to the collection and processing of data may be revoked at any time without affecting the lawfulness of the processing which was carried out on the basis of consent before its withdrawal.

7. Consent to collect and process personal data.

You consent to the collection and processing of personal data during the first contact (e-mail, telephone, contact form) with BM QUEER.
